#### **WEEK 2 HAPPENINGS**

I would like to thank parents/whānau for complying with our new street regulations. Namely, that the carpark behind the library which is now for the staff. The bollards along Church St have certainly made the crossing from the school buildings to our back field so much safer for our children to access. Many parents hadn't realised the back field was in fact our school's land. It is incredibly strange to have a street dissecting our school! My understanding is back in 1953 the land was purchased for the school which is awesome, otherwise it is likely to have been residential housing. The Playcentre and Waverley kindergarten are on our school land.

The new street layout (and temporary placement of bollards 8:30am – 3:30pm on school days) is for a 12 month trial period and then TDC in conjunction with Richmond School and the Ministry of Education will make decisions about what will happen permanently. Towards the end of the trial period the community will be consulted about their views. Some parents have already done so and that's fine during the trial period. There are already some suggested modified to be actioned in the next few weeks and months. The bottom-line for us – our students' safety is paramount.





On Tuesday afternoon in the hall, our combined Middles and Seniors kapa haka group performed to the school and parents. An excellent performance.

I want to assure parents that we have been dealing recently with a group of teenagers hanging around on the top of Church Hill by the main church door prior to the school day. They have been upsetting a number of our

children and parents. We have been speaking to the church, the police, management of the school they are attending and parents of some of the children. We are hopeful our efforts have solved these issues. Please let me know if your children or you experience any further issues.

#### PHYSICAL RESTRAINT POLICY

The school Board develops policies and reviews them. At our 28<sup>th</sup> June 2023 Board meeting there were a number of changes made to our 'Physical Restraint of children' policy. The changes were primarily due to amendments to the Education Act and the new Ministry of Education rules and guidelines that came into effect on 7<sup>th</sup> February 2023.

One of the guidelines states: "Early each year the principal shall inform the parent/caregiver community via the weekly school newsletter about the policy and include the policy in the newsletter."

Physical restraint is a severe intervention. It is seen as the 'last resort' of action and infrequently used. If there is an alternative to physically restraining a student, we use the alternative. Teachers and authorised staff members must act reasonably and proportionately in the circumstances to achieve a safe environment for students and staff.

The policy is attached for parents to view.

#### RICHMOND SCHOOL POLICY STATEMENT H16

## Reducing student distress and the use of Physical Restraint

#### **RATIONALE:**

The Board of Trustees recognises its responsibility to ensure that the school is a safe and healthy place for its employees, students and other people. Every school must have a policy on managing challenging behaviour and using physical restraint that is consistent with the Reducing student distress and the use of Physical Restraint of Children rules (amendment to the Act Section 139AD).

#### **PURPOSE:**

To ensure that the procedures of the school are compliant with the changes to the Education Act 1989 in regard to the Physical Restraint of Children rules (amendment to the Act Section 139AD) that came into force on 15<sup>th</sup> August 2017 and the new rules and guidelines that came into effect on the 7<sup>th</sup> February 2023.

#### **GUIDELINES**:

- When there is a need to restrain children then employees must comply with recent changes to the Education Act 1989 in regard to the Physical Restraint of Children rules (amendment to the Act, Section 139AD) that came into force on 15<sup>th</sup> August 2017 and the new rules and guidelines that came into effect on the 7<sup>th</sup> February 2023.
- 2. The Act defines 'physical restraint' as using physical force to prevent, restrict, or subdue the movement of a student's body or part of the student's body.
- 3. Physical restraint is a severe intervention. It should be seen as the 'last resort' of action.

The Ministry of Education's updated:

Guidelines for Registered Schools in New Zealand on the Use of Physical Restraint [PDF, 279 KB]

aim to minimise the use of physical restraint. Please note:

- If there is an alternative to physically restraining a student, use the alternative.
- Teachers and authorised staff members must act reasonably and proportionately in the circumstances to achieve a safe environment for students and staff.
- 4. A teacher or authorised staff member must not physically restrain a student unless:
  - The teacher or staff member reasonably believes that the safety of the student or of any other person is at serious and imminent risk; and
  - The physical restraint is reasonable and proportionate in the circumstances.
- Do not use physical restraint for behaviour that is disrupting the classroom <u>but not</u> putting anyone at risk of injury:

- for refusal to comply with an adult's request
- in response to verbal threats
- to stop a student who is trying to leave the classroom or school without permission
- as coercion, discipline or punishment
- for damaging property, unless this could cause injury
- 6. When a student regularly presents a heightened risk of serious injury to themselves or others, an Individual Behaviour Plan should be developed.
- 7. Every employer must take appropriate steps to ensure that parents, students, school staff and the community know about the school's policy for managing challenging behaviour and using physical restraint. Early each year the principal shall inform the parent/caregiver community via the weekly school newsletter about the policy and include the policy in the newsletter.
- 8. Staff members must be familiar with the requirements of this amendment and this policy. Management will provide on-going professional guidance, reminders and support regarding the Education Act Section 139AD amendment and the new rules and guidelines that came into effect on the 7<sup>th</sup> February 2023, our policy and our procedures.
- 9. Every staff member who uses physical restraint must complete a staff physical restraint incident report (refer to form attached). The employer must place a copy of the form in the student's file and provide a copy to the student's teacher, parent and/or caregivers.
- 10. The Principal (or Associate Principal) will send to the Ministry of Education (Wellington) completed physical restraint incident forms within a few days after the Physical Restraint incident has occurred. A copy must be kept for a minimum of ten years. These will be kept in a 'Physical restraint incident forms' file located in the principal's office.
- 11. The Board (via the principal) is accepting of the Principal, Associate Principal, teachers and authorised teacher-aides undertaking physical restraint as deemed appropriate as per the school's policy and procedures. They must be suitably supported and trained.
- 12. The principal will keep a record of authorised teacher-aides. Every authorisation must be in writing. The principal must provide the authorised teacher-aide with a copy of this authorisation. The principal may, by written notice to the employee, revoke an authorisation at any time.
- 14. Management will take all appropriate steps to ensure parents/caregivers are notified if physical restraint is an element in a student's Individual Behaviour Plan. There will be an explanation of how physical restraint will be applied in accordance with the Education Act (Section 139AD amendment) and the new Ministry of Education rules and guidelines that came into effect on the 7<sup>th</sup> February 2023.
- 15. The principal will ensure parents/caregivers are notified as soon as possible on the same day about any incident of physical restraint, including how it was management in accordance with the new Ministry of Education rules and guidelines that came into effect on the 7<sup>th</sup> February 2023.
- 16. Every employer must take appropriate steps to ensure that, for any student who has been physically restrained and for any staff member who has used physical restraint, their physical and psychological well-being is monitored for the rest of the school day following an incident of physical restraint.
- 17. The principal will check the documentation about each incident and make sure it is completed.
- 18. All physical restraint incidents will be reported at the next Board meeting and the Board will be kept informed of all relevant information (risks, trends and impacts).

18. All injuries and first aid treatments that are prior to or an outcome of the physical restraint incident and are thought to be serious (to staff and/or children) must be recorded in the First Aid register.


#### **CONCLUSION:**

By implementing appropriate reducing student distress and the use physical restraint of children procedures and methods, the Board of Trustees and management will be complying with the regulations noted in the Education Act (Section 139AD amendment) and the new Ministry of Education rules and guidelines that came into effect on the 7<sup>th</sup> February 2023.
